1 Introduction

This document specifies the supplementary SAC criteria for the certification of Business Continuity Management (BCM) Systems, and is to be used with ISO/IEC 17021.

2 Criteria for BCM Auditors

2.1 A certification body shall appoint qualified auditors to conduct BCM audits. Auditors shall meet the criteria as defined in Annex 1 of this document.

3 Duration of BCM Audits

- 3.1 Where applicable, references shall be made to the IAF Mandatory Document for Duration of QMS and EMS Audits Issue 1 (IAF MD 5).
- 3.2 For initial audit, the minimum audit duration (Stage 1 + Stage 2) will be as indicated in Table 1.

- 3.4 Surveillance audit duration = 1/3 of initial audit duration
- 3.5 Recertification audit duration = 2/3 of initial audit duration

Criteria for BCM Auditors

The summary of the BCM Auditors' criteria is tabulated below.

Auditor Training	 Successfully completed and passed a 5-day licensed or registered examination course for business continuity covering the SS 540 or ISO 22301 BCM framework Successfully completed and passed a recognized Auditor / Lead Auditor course for Business Continuity Management or recognized Auditor / Lead Auditor course for risk-based approach management systems.

Criteria	BCM Auditor	BCM Lead Auditor
Audit Experience (Audits may include risk based approach management systems)	Performed a minimum of 4 audits within a 2-year period with a minimum of 10 auditor days on site.	Same requirement as for auditor. Performed additional minimum of 3 audits as a lead auditor-in-training within a 2-year period. Note: An auditor must perform a minimum of 7audits within 2 year period before he or she is qualified to be a Lead Auditor.
Maintenance of qualification (once every 3 years)	Performed at least 5 BCM or risk based audits at the end of every 3-year cycle.	Same requirement as for auditor. At least 2 of these audits performed shall be in the capacity as the audit team leader.

Notes:

- 1) Approval of BCM auditors can be done internally by a certification body to perform BCM audits.
- 2) BCM audits such as initial, surveillance or recertification audits. 2nd party audits (supplier / vendor audits) performed based on SS 540 or ISO 22301 can be considered as audit experience stated in this document. All audits have to cover the critical processes.
